MINUTES

CALL TO ORDER

The meeting was called to order by Mayor David James on Friday, June 3, 2005 at 9:00 a.m.

ROLL CALL BY RECORDER

Roll call was taken by City Recorder Debbie Beadles. Present were D James, R Haskins, C Moody, T Pettigrew, K Dillon, T Mulcahy, D Beadles and one media personnel.

BUSINESS

FORESTDALE BRIDGE UPDATE/ACTION

Ms. Dillon stated she had gone over the original maps, plans and proposed land acquisitions. She stated there are ten property owners with whom to negotiate right-of-ways. She stated Hubert Maynard had spoken with Jerry Hughes and Greg Duncan. She stated the commission has requested an itemized engineering cost account, explanation as to the elaborate cost of the bridge and requested representative from TDOT meet with commission to answer questions about bridge project. She stated Hubert is waiting to hear from Mr. Duncan as to when he can meet with the board.

Ms. Dillon recommended that board request a meeting of property owners, explain financial dilemma of city and negotiate property and request they donate the right-of-way property.

It was the consensus of the board that letters be sent to property owners after Ms. Dillon hears from TDOT. It was mentioned that board set up meeting at the end of next week (after meeting with Mr. Duncan) to make decision about bridge.

CDBG SURVEY UPDATE/ACTION

Ms. Dillon stated the commission had made a motion to advertise to solicit volunteers with a financial incentive. She stated she met with Glen Melton, Work Force Program, who informed her of a state implemented program that employs young people 18 to 21 years of age, thirty to forty hours per week for eight weeks at no expense to the city. She stated that city participate in this program, request up to fifteen people and allow the participants to circulate the CDBG surveys to residents. She stated Doris Owens, grant writer, would train the participants in completing the surveys.

The board requested city manager to invite pastors/ministers of area churches to next regular meeting where importance of CDBG surveys would be explained and put first on agenda.
